1. Student Pass

a. For Full- Time International Students

To apply for student pass, please access <https://www.ica.gov.sg/pass/studentpass/ihl> to submit the Student's Pass Online Application and Registration (SOLAR) electronically.

- SOLAR Information can be found in Offer Acceptance Confirmation email. Please check inbox/ junk mail after you have accepted the offer.
- Please check all information in SOLAR before submitting your Student's Pass application.

Note: Please do not make any early travel plans without IPA letter.

b. Immigration Pass (Part- time International Students)

International Students who are not a citizen or Permanent Resident of Singapore must ensure that they possess a valid immigration pass issued by ICA or Ministry of Manpower (MOM) to study and reside in Singapore throughout the entire period of their studies.

2. Online verification via E-verification portal

To complete the verification process, kindly refer to this [link](#). It contains all the necessary information and instructions regarding the verification procedures. We recommend reviewing the guidelines carefully and taking the required actions promptly.

All students must login to the E-verification portal to complete the form and upload required documents. When completing the form, please ensure your keyboard setting (Language Preference) is "English" and not other languages.

Documents to be uploaded into the E-Verification Portal

- a. For **Conditional Offer** (i.e. subject to attaining a Bachelor/ Masters' degree), you are required to upload **Bachelor/ Masters' degree scrolls and Official Transcript** (Original and English Language translated).

If you are unable to upload Bachelor/ Masters' degree scroll during verification period, you are to upload a **letter of completion** from your university stating that you have completed and attained Bachelor/ Masters' degree.

Do not complete e-verification if you did not meet the condition stated on the offer letter. Kindly contact your school for assistance.

- b. **Degree Verification Report (in English)**

All students who are issued with overseas degree are required to obtain an official verification report from an NTU approved credential verification agency. Do refer [here](#) for the approved verification agencies. Verification of the highest qualification is mandatory if you possess multiple degrees.

Please ensure that you upload the degree verification report within one month from 12 January 2026. It is important to note that if you are on a scholarship, failure to provide the report by 28 February 2026 will result in the withholding of your stipend.

- c. **Full time international students - Valid Student's Pass (Front and Back or digital copy)** issued by Immigration and Checkpoint Authority of Singapore (ICA).
This will be available once you had completed the formalities by ICA.
- d. **Last day of Employment Letter** (applicable only for students who resign to pursue PhD/Master at NTU).
- e. If you are currently pursuing a degree at another university, please provide a **termination letter** from your previous university as proof of your withdrawal from the program in order to pursue your PhD/Master's degree at NTU. This requirement is applicable only to students who fall under this category.

If the Office of Admissions has notified you about any additional documents required, please ensure that you furnish those documents accordingly.

Update of Emergency Contact, Singapore Mailing Address and Contact Number

All students must update these in Online Verification form. If Singapore mailing address and Singapore contact number are not available upon submission of online verification form, you are required to update the information in Graduate Student Link (GSLink) / Student Intranet once accessible.

3. Online Matriculation

Please ensure you have completed Point 2 - Online verification via E-verification portal before you proceed to Point 3.

All students must complete [online matriculation](#) to become a registered student of NTU. Your name would not be registered to the University's register if you do not matriculate online.

Please ensure that you have completed the following procedures before proceeding with Online Matriculation:

- Accepted Offer, Obtained Matriculation number, and Created Network Account
- Completed Online Verification
- Obtained IPA letter (For Full time international students)
- Obtained Employment Pass / S Pass (For Part time international students)

4. Pre-enrolment Medical Check-up

The offer of admission is made to you subjected to the condition that the University is satisfied that you have the medical fitness to pursue the programme of study. Therefore, **all students, except Part-Time students**, MUST undergo a health screening prior to admission to determine their medical fitness.
