Course Aims

This course aims to provide you with a basic understanding of fundamental theoretical concepts in computability and complexity and achieve a rigorous understanding of basic automata theory. You will learn the rigorous way to approach mathematical problems in these topics and to be familiar with the process of solving abstract problems related to computability, complexity and automatic theory. Through this course, you will have opportunity to sharpen your critical analytical skills in an interdisciplinary realm of computer science and mathematics, and improve your communication skills necessary to deliver technical ideas to a broad audience. As a result of this course, you will develop the necessary skills to become ready for career in computer science or mathematically related fields.

Intended Learning Outcomes

Upon successfully completing this course, you should be able to:

- 1. Distinguish between different models of computation.
- 2. Apply the definitions of formal languages and grammars.
- 3. Explain the workings of a finite automata.
- 4. Derive the relationship between finite automaton and regular expressions.
- 5. Employ the use of the pumping lemma to tell which expressions are regular.
- 6. Explain the workings of a pushdown automata.
- 7. Derive the relationship between a pushdown automata and context free languages.
- 8. Apply the pumping lemma for context free languages.
- 9. Describe the formal model of a Turing machine.
- 10. Distinguish between the different variations of a Turing machine.
- 11. Perform the diagonalization argument on different problems.
- 12. Differentiate between computable and noncomputable problems.
- 13. State the difference between a deterministic and a nondeterministic Turing machine.
- 14. Judge which problems are in P and which are in NP.
- 15. List the examples of classes that are NP-complete.
- 16. Apply Cook's Theorem to determine if a given problem is NP-complete.
- 17. Derive the ingredients of the complementation theorem for NP problems.

Course Content

Introduction to models of computation and finitary representations.

Formal languages and Chomsky's grammars.

Finite automata, regular expressions, regular grammars, and their equivalence.

Properties of regular languages: pumping lemma for regular languages and its applications.

Pushdown automata, context free languages and context free grammars.

Properties of context free languages: pumping lemma for context free languages.

Turing machines: definition and construction for simple problems.

Church-Turing thesis and computability.

Uncountable numbers and the diagonalization argument.

Examples of non-computable problems and applications.

Computably enumerable sets and Post's problem.

Nondeterministic Turing machines and the classes P and NP.

Polynomial-time reductions and Cook's Theorem.

Satisfiability and other NP-complete problems.

Co-NP space.

Rubric for Tutorials: Project (15%)

Please Note: In principle, students in the same group share the same group marks. Students may be awarded more marks for showing exemplary contribution to other team members' learning that goes beyond what is required, whereas students who have not contributed sufficiently may receive lower marks than the rest of the team members.
