Course Aims

Community psychology (CP) examines individuals and communities in context and applies this knowledge to promote positive change and well-being for individuals and the wider society. In this course, you will learn the development of community psychology and it values, theories, concepts, and prominent approaches to research. You will examine these in topics relevant to the Singapore context (e.g. aging and sustainability) to allow you to connect learnt content with local issues, as the fundamental aim of community psychology is to integrate research and action to solve social problems. Understanding psychological processes at the community level and learning to apply knowledge for action is valuable to those who seek a career in research, policy making, and advocacy, to name a few.

Intended Learning Outcomes (ILO)

By the end of the course, you should be able to:

- 1 Explain how the field of community psychology developed
- 2 Describe key theories and concepts in community psychology
- 3 Describe different methods of research with communities
- 4 Discuss the limitations and applications of key theories, concepts, and methods of community psychology
- 5 Apply theories, concepts, and research methods of community psychology to address social issues of local community

Course Content

The course is divided into two sections. First, we cover the development and values of community psychology, common theoretical frameworks (e.g. ecological and systems thinking), approaches to research (e.g. participatory methods and programme evaluation), and core concepts (e.g. prevention, promotion, social change, empowerment, community, participation). Next, we adopt a community psychology lens to examine social, health, and sustainability topics pertinent to Singapore (e.g. immigration, racial harmony, aging, and environmental sustainability).
