

OVERSEAS ENTREPRENEURSHIP PROGRAMME APPLICATION FORM

1. Programme Objective:

The Overseas Entrepreneurship Programme (OEP) provides entrepreneurially minded students with an opportunity to intern at dynamic startups across the globe.

2. Programme Details:

- Six month or one year internship with an overseas startup
- Students will enter the country on an internship visa where possible. In the event that an internship visa is not available, students will need to apply for a student visa
- OEP students will be paid a monthly stipend by the host startup and may receive subsidies for air ticket(s), insurance and visa (*terms and conditions apply*)
- Students are expected to incur differentiating level of expenses, depending on destination and personal lifestyle. These include accommodation, initial settling-in costs, telecommunications and daily subsistence

3. Applications

- Students interested to apply for the programme must submit the completed application form, together with the following:
 - a resume
 - your latest degree audit
 - an essay
 - a self-introduction video

- Students should possess the maturity to thrive in a foreign and highly competitive environment.
- Students on scholarships must check with their respective scholarship administrators or providers on their eligibility prior to applying for OEP.

4. Selection Process

- **Selection:** All applications will be reviewed and evaluated by a selection panel.
- **Company-matching:**
 - Students who are selected for the programme will be matched to startup companies, based on their preferences
- Students going to a location that offer courses at a partner university will need to apply directly for the modules they intend to take.
- The selection criteria used by NTC will not be disclosed. NTC reserves the right to withdraw the application of selected candidates and decide on the year of internship.
