#### **(to be signed by the parent/guardian of TCEP participant/student)**

1. I am applying for my child to be a participant or student of the Top Chinese Enrichment Programme (“**TCEP**”) conducted by Confucius Institute, NTU (“**CI-NTU**”).
2. By signing and submitting this Declaration to CI-NTU, I give consent on my child’s behalf to CI-NTU to collect, use, disclose and process my child’s Personal Data for the following purposes:
  - a) Evaluate and process the TCEP programme application;
  - b) For TCEP programme administration or management;
  - c) To deal with any matter related to my child’s participation in the TCEP.
