The Master of Public Administration (MPA) programme will enrich your learning experience, providing you with a uniquely immersive environment to engage in real-world issues, as you prepare to take your career in policy-making and public administration in Asia to the next level.

PROGRAMME STRUCTURE

The programme is offered on both full-time and part-time basis, with the curriculum consisting of 8 courses (2 core courses and 6 electives) and a capstone paper. With interactive seminar lessons with policy case studies drawn from Asia – including Singapore, ASEAN and China – insights from classroom can be applied to real world settings in the public and private sector.

ADMISSION REQUIREMENTS

- A bachelor's degree in good standing from an accredited university or college is required for all applicants.
- At least two years' or more of full-time work experience after obtaining your bachelor degree
- For students from universities whose medium of instruction is not in English, an English proficiency test, for example, IELTS/TOEFL is required.

PROGRAMME FEE

The programme fee is **S\$32,299**, inclusive of the prevailing Goods and Services Tax.

The fee does not cover health check-up, entry visa, student pass, accommodation, meals, overseas study trip, attachment, miscellaneous fees, etc. The tuition fee is payable on an installment basis.
