1. Full-time students will normally take 2.5 years to complete their programme, while part-time students will normally take 3.5 years. Students who need additional time to complete their programme will be charged the applicable tuition fee rate for the additional semester(s) required.
2. All fees listed above are in Singapore dollars (S\$). Every year, fees are reviewed and subject to revision. As and when fees are revised, the new fees will be applicable to all existing and new students. Fees are subject to applicable GST.
3. There are two semesters in an academic year. Fees payable every semester must be paid in advance and within the stipulated period.
4. Persons who fail to pay fees within the stipulated periods can have their names removed from the register of higher degree students. A person whose name has been thus removed but who is otherwise eligible to continue his candidature will be reinstated only after he has settled all outstanding fees and paid a re-registration fee of S\$53.50 (inclusive of GST).
5. A student who withdraws or leaves the University two or more weeks after the commencement of his candidature or the commencement of the semester is liable to pay the fees due for the semester.
6. The University's Board of Trustees reserves the right to alter fees at any time without notice.

- Candidates who withdraw from the programme within the first 2 weeks of the first semester shall not be liable for the Tuition Fee, and Miscellaneous Fees. Candidates who withdraw from the programme after the second week shall be liable for payment of Tuition Fee, and Miscellaneous Fees due for the entire semester.
